3. Place, conditions and terms of works performance:

Place of works performance: Sochi, Krasnodar Territory;

Term of works performance: 22 months minimum; 30 months maximum

The works are financed from the federal budget. The mode of payment is bank transfer. The payments will be provided by developer on terms and conditions which are set in the state contract project. The developer makes advance to the contractor of 30 % of the limit of budget obligations provided in appropriate order in 2010 on conditions that developer gets funds from the federal budget.

The payment will be made strictly within the limits of the budget obligations provided in appropriate order in certain year (2010, 2011, 2012).

10. Amount of payment for securing of execution of the state contract.

30 % of the initial (maximum) contract price:

– **3 200 977 464** (*three billion two hundred millions nine hundred seventy seven thousand four hundred sixty four*) rubles.

The state contract will be concluded only after providing the securing of execution of the state contract to the Developer by winner of the bidding (or by participant which application obtained No 2 in case when the winner is considered eluding from conclusion of the state contract).

The securing of execution of the state contract may be provided as irrevocable bank guarantee, contract of guarantee or contract of transferring the pledge to developer, including transfer in form of deposit equal to the volume of securing of execution of the state contract stated in the bidding documentation.

The mode of providing the securing of execution of the state contract is subject of choice of the bidding winner (or participant of the bidding concluding state contract).
